OOSH (Out of School Hours):

\$15 before school care (\$17 for each casual booking)

\$20 after school care (\$22 for each casual booking)

Vacation Care:

\$55 per day, per child plus \$20 per child for any extra excursion or incursion.

Enrolment Conditions

1. Payment of Fees

- Fees will be invoiced at the start of each year, payable within 14 days, unless you have an approved payment arrangement.
- A direct debit facility will be established upon enrolment and fees charged to a nominated credit card or savings account.
- Alternative forms of payment (E.g. cheque, cash, BPAY or credit card) are only available by arrangement when an acceptable payment history has been established. Late payers will be required to pay by direct debit only.
- A late fee applies for families that are behind in their payment plan or do not have a payment plan. The late fee will be as follows:
 - \$50 for term payment plans or no payment plan
 - \$20 for monthly payment plans
 - \$10 for fortnightly payment plans
 - \$5 for weekly payment plans
- Families risk their children to be suspended or their position declared vacant if a payment arrangement is not actioned or complied with.
- A surcharge is applicable for payments made by debit card (0.5%) or credit card (0.9%).

2. Other Fees Payable

Application Fee (Inc GST)	each student	\$100*
Acceptance Fee	each student	\$500 **
Yearly Trust Fund	each family	\$460***

(*) This amount less GST will be offset against term one fees upon completion of an enrolment survey and direct debit forms.

(**) Payable on acceptance of offer and is non-refundable.

(***) Refundable upon written application to the Trustee (addressed to the school) within three months of the last child in the family leaving the school.

3. Notice Required on Leaving

If any students are withdrawn before the completion of Year 12, written notice of ten (10) teaching weeks is required or an in lieu of notice fee representing one term fees will be charged.

4. Scope of Tuition Fee Payments:

Text books, exercise books, excursions, sporting and camp fees are provided by the school, except for some materials for TAS/VET subjects and sporting events beyond zone level. Families who participate in CIS and CSSA national sporting competitions are responsible for the payment of fees before participating in these events. Payments are made to the Uniform Shop.

Child 1 in the fee schedule is deemed to be the eldest child attending William Carey. Fees are adjusted yearly according to prevailing conditions.

5. Building Fund

Families are encouraged to donate to the Building Fund. Donations to the Building Fund are fully tax deductible.
